





NEMAHA COUNTY HISTORICAL SOCIETY, INC. HISTORY

At a meeting on February 19, 1976, in the Seneca Mayor's office, the Nemaha County Historical Society, Inc. was organized as a 501c3 private, nonprofit organization "to collect, preserve and display historical records and items of Nemaha County, to encourage interest in local history...."

The Seneca City Council provided the Historical Society with several rooms on the second floor of City Hall in which to begin collecting historical artifacts and archives. Amelia Sudbeck (1932-1991) was designated the registered agent of the corporation. Her relentless dedication and devotion to the preservation of Nemaha County History for future generations is revealed in the current museum.

The Grand Opening of the Nemaha County Historical Museum was scheduled to coincide with the Seneca Bicentennial celebration on July 2nd and 3rd, 1976. The Nemaha County Historical Society, Inc. bought the former Nemaha County Jail and Sheriff's Residence in 1978 from Mr. Winterscheidt who had purchased it at auction. The Historical Museum was established in the Jail and Sheriff's Residence.

- Harry C.M. Burger funded the building of Annex One in 1995 and Annex Two in 2004. The Nemaha County Genealogical Society was affiliated with the Historical Society in 1994 and disbanded in 2007. NCGS Records were accessed into the Genealogical Research Collection at the Historical Museum. The Seneca Masonic Organization donated the Temple of Honor Military Museum building to the Nemaha County Historical Society in 2011.
- The Jail and Sheriff's Residence was placed on the Registry for National Historic Places in 2006.

 The NCHS applied for and received a Heritage Trust Fund Grant in 2006 to develop a preservation plan and began restoration of the building and another HTF Grant in 2007 to repair the front porch on the Sheriff's Residence. The NCHS applied for and received Kansas Humanities Council Grants beginning in 2006 to inventory, catalog, label and preserve all the items in the museum.
- NCHS volunteers have assisted with placing twelve historic places in Nemaha County either on the Registry of Historic Kansas Places and/or the Registry of National Historic Places. And NCHS volunteers have assisted five organizations with applications for Heritage Trust Funding and continues to serve as custodian of Nemaha County Governmental & Corporation Historic Records.

Objectives

Established in By-Laws & Constitution: February 1976

This incorporated society is organized as a NOT-FOR-PROFIT organization and none of any parts of its earnings benefit any individual. The nature of its business or purpose to be conducted or promoted shall be to bring together those people interested in history, and especially in the history of Nemaha County, Kansas. Understanding the history of our community is basic to our democratic way of life; gives us a better understanding of our state and nation, and promotes a better appreciation of our American heritage.

The corporation's major function will be to discover and collect any material which may help to establish or illustrate the history of the area; its exploration, settlement, development, and activities in peace and in war; its progress in population, wealth, education, arts, science, agriculture, manufactures, trade and transportation. It will collect printed material illustrative of life, conditions, events and activities of the past and present.

The society will provide for the preservation of such material and for its accessibility, as far as may be feasible, to all who wish to examine or study it; to cooperate with officials in insuring the preservation and accessibility of the records and archives of the county and of its cities, towns, villages and institutions, and to undertake the preservation of historic buildings, monuments, and markers.

The society will disseminate historical information and arouse interest in the past by publishing historical material in the newspapers or otherwise; by holding meetings with pageants, addresses, lectures, papers and discussion; by marking historical buildings, sites, and trails; and by using the media of radio and television to awaken public interest.

Saving The Jail & Sheriff's Residence

Window Rehabilitation: This project rehabilitated the 1879 windows in the residence and the 1907 windows in the jail. These windows, an important part of the historic character of the building, comprise a view of the historic fabric of this community and preserve an artifact of the past. Without this \$40,000 window project, this historic building was threatened with irreversible destruction to the parts of the building.



Roofing-Masonry Project

Roofing-Mortar Project: To fix the roof over the Sheriff's Residence and Jail before winter set in, bids went out in the summer of 2016. The rains and early freeze on Thanksgiving Day 2015 caused severe damage to the roof and allowed water to leak into the interior. The insurance company would not pay for the damage. Doug Berkley was chosen to shingle the sheriff's residence at a contracted cost of \$9,200.00. Doug also installed vents to reduce the chance of moisture build-up in the attic. It will make roofing shingles last longer and reduce the chance of ice dams. The flat roof on jail was completed by Midwest Roofing at a cost of \$6,200.00. Unruh Guttering completed the new guttering at a cost of \$4,700.00. The total spent for the project to date is \$20,105.94. The Project fund has an \$12,500 grant award from S.T.E.P. Nemaha County Community Organization and \$17,500 in matching funds for this project. The external mortar work and interior ceiling estimated work will be scheduled for 2017. Additional grant funds will be sought to complete this project.

Temple of Honor Restoration Project, step one:



The Classical Revival style of the Seneca Masonic Temple is unique to Seneca, Nemaha County and Northeast Kansas. It represents the influence that Masonic Lodges welded in Kansas and across the United States from the late 1800s to the 1950s. In Seneca, the Masonic Lodge No. 39 A.F. & A. M. organized in September 1863 combining with the Grand Army of the Republic and the Royal Arch Masons who organized in 1877. After the Masonic Temple was gifted in 2011 to the Nemaha County Historical Society, it became the home for the organization's military museum. The City of Seneca and the Seneca American Legion moved a Civil War Cannon and World War Two Priest (tank) as permanent displays to the grounds of the Masonic Temple.

The Kansas Preservation Alliance deemed the Seneca Masonic Temple as an "endangered place" in 2014 and partnered with the Architectural, Engineering and Construction Departments of the Kansas State University to access and recommend repairs to keep the Seneca Masonic Temple building in service and code compliant. This year long project involved a site visit, individual research and classroom discussions. Their individual, final reports were collected and presented as one preservation plan which provides realistic suggestions for this project to prevent further damage and deterioration while enhancing functionality and visitor experience. These reports were used to apply for the 2016 Kansas Heritage Trust Fund.

\$88,960.00 funding was awarded by the 2016 Kansas Heritage Trust Fund HTF towards this \$111,200.00 project which will provide professional direction, drawings and construction work to protect the building from further moisture damage and deterioration while addressing safety issues.


Tourism

Computer Upgrades

Marcia and Mike Philbrick took inventory of hardware/software on all the museum's computers and upgraded them to Windows 10 in 2016. They requested and received two Lenovo laptops from USD 115 which were upgraded to Windows 10. They also upgraded video connections to digital for two computers and received two computers from Kansas City Geeks, Inc. Microsoft Office 365 without Publisher was added to computers free of charge. now sharing research on the current website that Janet Ackerman Hicks developed and they are working together to keep the information current. Marcia started a blog to generate interest in the website and added local historical stories and research. Marcia has applied for a grant to help pay for setting up social media and is encouraging virtual tours of each room in the museum be developed as an excellent addition to the website. Alma Ackerman maintains the NCHS face book page.

Minutes of Annual Meeting February 9, 2016

The 2016 Annual Meeting of the Nemaha County Historical Society began with a covered dish dinner at 5:00 P.M. on February 9, 2016 in Annex One. Following dinner, Anita introduced our guest speaker Dr. Gena Holthaus, daughter of Board member Karen Holthaus. Dr. Holthaus, who has a vigorous interest in the Civil War, is a veterinarian at Stone House Animal Hospital in Topeka. Following Gena's interesting and informative presentation, the business portion of the Annual Meeting was called to order by President Anita Heiman. Board members present were DarlAnn Rial, Anita Heiman, Freda Dobbins, Greg Newlin, Raymond Thieme, Joyce Olberding, Karen Holthaus, and Patty Byers. Also in attendance for the Annual Meeting were 10 guests.

- <u>Secretary's Report:</u> The minutes of the February 10, 2015 Annual Meeting were presented by Patty Byers. DarlAnn moved and Karen seconded the motion to accept the minutes as presented. Motion carried.
- <u>Treasurer's Report:</u> Treasurer Raymond Thieme presented the Financial Report for 2015. Beginning balance as of January 1, 2015 was \$21,037.54, with a total yearly income of \$65,625.86. Total expenses for 2015 were \$38,708.03, leaving an ending checking account balance on December 31, 2015 of \$47,955.37. Greg moved and Joyce seconded the motion to accept the Financial Report as presented. Motion carried unanimously.
- <u>Bancroft Report:</u> Freda presented the Bancroft Preservation Association Report. The beginning balance as of January 1, 2015 was \$1571.68. Deposits for 2015 were \$6423.00. Expenses for 2015 totaled \$6443.45, leaving a balance as of December 31, 2015 of \$1551.23. DarlAnn moved and Greg seconded the motion to accept the Bancroft Report as presented. Motion passed unanimously.
- <u>Audit Report:</u> Karen presented the Audit Report. No discrepancies were found and all matters were in order. Freda moved and Greg seconded the motion to accept the Audit Report unanimously.
- Old Business: Fundraising: Anita directed the Board members to the Treasurer's Report for receipts from the Golf Tournament, Tractor Cruise, and Highway 36 Garage Sale. She noted that plans for the 2016 Golf Tournament are moving along, and that we are already receiving donations for the Highway 36 Sale.
- New Business: Membership Dues Increase: DarlAnn reported Membership Chairman Alma Ackerman has recommended an increase in dues for 2016 to reflect the following: Individual memberships-\$20; Business memberships-\$35; Lifetime memberships stay the same. DarlAnn moved that the Board accept Alma's recommendations as of February 9, 2016. The motion failed due to a lack of a second. Following discussion, Freda moved and Greg seconded the motion to accept Alma's recommendations as of January 1, 2017,. Motion carried with one nay vote.
 - Landscaping Plan: Greg presented his plan for parking and landscaping the land between the Sheriff's residence and the alley. It was noted that without a cost estimate no action was taken.
 - **Election of Board Members:** Freda nominated the following candidates to serve 3-year terms as Board Members: Anita Heiman, Position 1: Melvin Baker, Position 2; Martene Geyser, Position 7; Patty Byers, Position 12. The slate of Directors was approved by acclimation.
- Other: The 2016 Reorganizational Meeting for the Nemaha County Historical Society was scheduled for March 8, 2016 at 5:00 P.M. in Annex One. With no further business, the 2016 Annual Meeting for the NCHS was adjourned.

The Bancroft Preservation Association has cared for the Bancroft Depot Museum area plus the 100+ year old Church and the one-room schoolhouse across the street from the Depot since the opening of the Museum in 1995. It took many volunteers several years of work and the donations of many others to get the Depot moved back into Bancroft and to renovate the Depot to be as near as possible to its original design. The Depot has housed not only railroad historical items, but also items from the community of Bancroft, from the Bancroft School and from life at the time the Depot was in use. There are especially many items related to the Kansas City Wyandotte Northwestern Railroad, on which the Depot was used. Each subsequent year saw additional items added to the Museum.

Following the May Bancroft Preservation Association Committee meeting, the Secretary sent this note to all the supporters and friends of the Museum. "Dwight D. Eisenhower defined the three stages of Live as (1) Youth, (2) Maturity, and (3) 'My, you're looking good!' The BPA Committee has reached stage three and are acknowledging we cannot continue with keeping the Association Active after this year. 'Looking Good,' doesn't preclude feeling bad and slowing down and so we see the need for decisions regarding the properties acquired by BPA. We look forward to your input ...by contacting any of the Committee."

As the end of 2016 approaches the Committee continues to look at all options for the future of the BPA. One of the primary purposes of the BPA was to preserve and display items related to Bancroft - the railroad, the community, the school. BPA feels it has been successful in accomplishing this purpose for the last 22 years. Many visitors have viewed the pictures and memorabilia and enjoyed the "memories" such items provide. All of this was accomplished through the help and support of all those who had an attachment to any part of the Museum. And even those who helped simply because they believe in preserving the past. The BPA Committee thanks each and every one of these supporters.

Considering the last day of service to Bancroft by KCWNW Railroad was October 31, 1919, and that the Bancroft High School closed in 1951, and the grade school in 1962, it is quite a feat for the Museum to still be a viable entity in 2016.

So with an unknown future, the BPA and Museum continue to preserve the history of the Bancroft Community and the Southeast corner of Nemaha County.
