The couple was staying in Marysville since the wife is a writer doing research on the Pony Express. She had read about our museum online and wanted to tour our facilities before she went to the Seneca Pony Express Museum. She was enthralled with our glass plate negative photos. Note that we are averaging one tour a week.

Dan Ronnebaum's sister, Mary Sack, came into the museum at 4 p.m. to pick up the final draft of the EMT History. She appreciates all the board's assistance with proofing the history. She also reminded us that the EMT organization has funds available and want to establish a memorial on the grounds of the Temple of Honor. He says there has been discussions about the high utility cost of the current forced heat unit and a possible replacement. I have not heard from Joe, but will add that to the discussion for estimates.

I did purchase a flexible hose from Seneca Hardware for \$21 to water the plants every day. We ask Diane to get the regular hose out of storage so that Greg can use on the other plants around the museum.
